ARTICLES OF INCORPORATION

These Articles of Incorporation are signed and acknowledged by the incorporators for the purpose of forming a non-profit corporation under the provisions of Act No. 327 of the Publis Acts of 1931, known as the Michigan General Corporation Act, as Follows:

ARTICLE I

The name of this corporation is KIWANIS CLUB OF COLDWATER MICHIGAN.

ARTICLE II

The purpose of purposes of this corporation are as follows:

- 1. To give primacy to the human and spiritual rather than to the material values of life.
- 2. To encourage the daily living of the Golden Rule in all human relationships.
- 3. To promote the adoption and the application of higher social, business, and professional standards.

- 5. To provide through Kiwanis clubs, a practical means to form enduring friendships, to rander altruistic service, and to build better communities.

- 7. To carry out the foregoing purposes, the corporation shall have power to receive and convey real and personal property and to receive and distribute gifts of property of all kinds.
