The Village has sent the paperwork to the State and do not anticipate having any problems transferring the property (proposed site for the new Union Twp. Library building) from the State to the Village (Union City). Because of that the attorney (for the Village of Union City) is starting the lease agreement between the Village and the Township and plans on having the agreement ready for the next meeting for both parties to approve.

Sebald presented photos of the proposed materials to be used for the exterior of the new library building.

Motion made by Gay, supported by Reppert, that our President, Dorothy Cherry send a letter to the Friends of the Union Township Library, as well as the Building Committee, outlining the concerns of the Branch District Library Board that ownership be established.
