Motion by Jewell, supported by Smith, to have the beginning date be on or before July 1, 2016. Motion carried.

Motion by Watson, supported by Gordon, to authorize the Search Committee to do further negotiations with Lyshol, taking it to the entire BDL Board for approval. Motion carried.
