We've had lots of programs, including Joel Tacey's Duct Tape Workshop; Dynamic West's "Shake, Rattle, and Roll"; the Zoomobile, Paula Dejong's "All Things Serenity" yoga program, and more. We were able to give jump ropes to all participating children this summer thanks to a donation from Modern Woodsman. Modern Woodsman also donated trees to the Village of Sherwood. Our Adult Reading Program starts October 3 and runs for six weeks, with a variety of gift baskets and gift cards as prizes.
