language of the Restricted Donations section is needed for the lawyers typically involved in trusts, estates and the like. Watson expressed concern that there might be confusion about the form attached to the policy as it is intended only to be used for monetary donations that aren't bequests, trusts, estates, etc. It was decided to try it as written now and, if problems occur, we can always amend it later.

Motion by Watson, supported by Langworthy, to approve the revised Gifts and Donations Policy. Motion carried.

## 8. Personnel Committee Report/Director's Performance Expectations Memo.

The Personnel Committee met on October 12<sup>th</sup> to review requests from the Director and to review the draft Performance Expectations Memo for the Director. The Director's requests will be going to the Finance Committee. Watson pointed out the changes and additions from last year's expectations memo. The biggest change is the addition of items related to the strategic plan. Motion by Watson, supported by Lowande, to approve the Director's Performance Expectations Memo. Motion carried.
