 1. Due to the reduction in the budget we have had to reduce library and staff hours. This led to the combination of the Circulation and Reference desk. At the end of December, the public computers as well as some of the collection were moved to help keep the loud and quiet areas of the library separate and to promote a better library experience for our patrons. Our Large Print collection remains on the ground floor as well as the DVD's. The magazines and New Books are now on the 2nd floor with the quiet reading area.
 1. Ralph Stevens had some concerns about noise, but reported that he can confirm usage of the Heritage Room also. Ralph also is concerned with trying to find things on the bottom shelves. Rucker mentioned that he is working with a company to get shelving at minimal cost to help with this situation.
3. Volunteer Luncheon - Bolton would like the board to start thinking about planning for the Volunteer Luncheon or something to honor the Volunteers in April.
