
RE: 2012-2013 Penal Fine Distribution

Please find enclosed your check for penal fine monies collected by District and Circuit Courts from July 1, 2012 thru June 2013. The per capita rate is 3.3359, an increase from the 2012 per capita rate of 2.4343. The total dollars to distribute to libraries from penal fines increased by 37.03% from 2012.
